***Homosexual Saints: The Community of Christ Experience***, edited by William D. Russell.

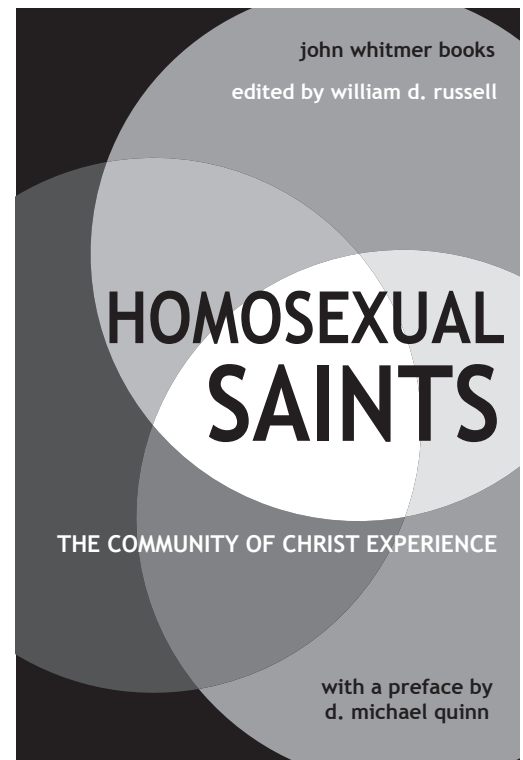
Members of Community of Christ (formerly the RLDS church) have polarized opinions concerning the status of their fellow members who are homosexual. The two major issues are priesthood ordination (in a predominantly lay church) and whether the church will marry and bless same-sex weddings.

*Homosexual Saints* explores these issues with twenty-four narratives that explain the experience of gay and lesbian members of Community of Christ, as well as the experiences of their family members and supporters.

**William D. Russell**, professor emeritus of history, Graceland University, has compiled these compelling stories and included a detailed history of the status of homosexuals in the church since 1954.

The work is prefaced by celebrated Mormon historian **D. Michael Quinn**.

The study guide offers a concise review of current sociological, public health and scientific data regarding sexual orientation and gender. It also considers key scriptural passages in light of contemporary understandings of sexual and gender diversity.

*A Time to Seek* summarizes the scientific research into the origins of sexual orientation and gender identity, and provides a glossary of relevant terminology. The study guide also provides data on the prevalence of sexual and gender diversity, demographics on same-sex couples and their families, and the status of marriage equality in the U.S. It also explores the psychological and social challenges faced by LGBT persons, particularly youth, and their families.

*A Time to Seek* is designed for individual or group study, with discussion questions aimed at specific religious concerns, such as the interpretation of scripture, the role of LGBT persons in faith communities, and the recognition of same-sex unions. An extensive resource guide is provided to encourage further exploration of sexual or gender diversity issues.

Washington – On October 4, 2007, the National Stonewall Democrats and more than 150 groups announced the launch of a united lobbying and advocacy campaign to win passage of the fully inclusive Employment Non-Discrimination Act (ENDA), H.R. 2015. United ENDA is a coalition and campaign to build upon the unprecedented solidarity in strategy demonstrated by more than 150 organizations determined to pass the original ENDA.

“National Stonewall Democrats are united in our support for the original ENDA which includes protections for both sexual orientation and gender identity,” said Jon Hoadley, Executive Director of National Stonewall Democrats. “We recognized early that this week would quickly become a tipping point in how our movement organizes and

how Democrats interact with our community. We have helped launch United ENDA in order to capitalize on that momentum and ensure that our party is pushed towards a winning strategy to end employment discrimination for working Americans."

National Stonewall Democrats was at the center of early organizing efforts to save the original Employment Non-Discrimination Act. Working with organizations such as the Task Force, and the National Center for Transgender Equality, Stonewall Democrats quickly helped organizers build a coalition that has now grown to more than 150 organizations.

United ENDA is the active lobby and campaign effort to pass the original Employment Non-Discrimination Act. It began with organizing a joint letter to Congress and quickly developed into a full campaign complete with grassroots and professional lobbying efforts. ...

NSD launched [NoSubstitutes.org](http://NoSubstitutes.org) as an online organizing tool to allow individuals to add their names to a growing list of Americans who support the original Employment Non-Discrimination Act. NSD used its contacts with these individuals to schedule in-district meetings with Members of Congress to urge support for the original bill.

Member organizations of United ENDA are communicating daily with Representatives to keep pressure on Congress. United ENDA will allow organizations to better coordinate lobbying strategies, grassroots mobilization efforts, online activism, media and legal strategies. The 150-plus organizations that share this position will continue to do their own lobbying, release their own statements and mobilize their own members, while the unified campaign will make sure that every organization has the latest information from Capitol Hill, the latest strategic plans and the most up-to-date reports from the grassroots.

Christian Leaders Call for Passage of National

### **U.S. Employment Non-Discrimination Act**

(ENDA)

the Bishops and Elders Council, a network of lesbian, gay, bisexual, and transgender (LGBT) affirming churches and organizations touching the lives of 98 million Americans, called on the U.S. Congress to pass the Employment Non-Discrimination Act (ENDA) and on President Bush to sign it into law.

Meeting in Sarasota, Florida, September 7-9, the Bishops and Elders Council noted the hundreds of scriptures in the Bible on economic justice. Deuteronomy 24:14 says, "You shall not withhold the wages of poor and needy laborers." According to Rev. Rebecca Voelkel, program director for The Institute for Welcoming Resources and a

convener of the Bishops and Elders Council, “Jesus crossed lines of all social divisions to include people in the realm of God. His opening sermon in Luke 4:18 proclaimed good news for the poor and to release the oppressed.” ...

Rev. Troy Plummer, executive director of the Reconciling Ministries Network, which works within the United Methodist Church, commented, “In a time of economic uncertainty for many Americans, LGBT people in most states face the added burden of being at risk for being fired at any time, or not being hired at all, simply because of their perceived sexual orientation or gender identity.”

The Bishops and Elders Council was founded September, 2006, in Dallas, Texas, and stated, “We are a unified body of followers of Christ who are committed to speak boldly in our own communities and the larger culture as those who have been both oppressed and oppressor. We will communicate God's consistent call for justice, wholeness and peace, and work to equip ourselves and others to take concrete action to achieve God's loving shalom. We are committed to work on

**Sometimes it's difficult to know whether one should celebrate or fight harder. Sometimes both are called for at the same time. The latest news from the House of Bishops of the Episcopal Church and the latest twist in the Federal Employment Non-Discrimination Act (ENDA) are good examples.**

**Bishops of the Episcopal Church met recently in New Orleans to face a truly daunting task: How to stay in the worldwide Anglican Communion and affirm the full participation of LGBT Episcopalians. As Anglicans have always done, the bishops tried to strike a compromise for the sake of unity. Sadly, the cost of that unity is once again being shouldered by LGBT people. In their published statement the bishops agreed to “exercise restraint” in electing any more gay and lesbian bishops but also affirmed the “full participation” of lesbian and gay people in the church.**

**On the legislative front, the long journey toward passing ENDA, which would protect lesbian, gay, bisexual and transgender people from workplace discrimination, seemed very close to passing in recent weeks. Sadly, in the 11<sup>th</sup> hour protections for transgender people were stripped from the legislation as a way to ensure its passage....**

**At what cost do we buy unity? Who pays the price for equality? These are not new questions. In the 19<sup>th</sup> century many churches sought unity at the cost of African slaves. Abolitionists in the same century worried that working for women's rights would dilute their efforts to abolish slavery. In the 1960s and 1970s the Episcopal Church, among others, debated church unity at the cost of the ordained ministry of women. Christian unity and social progress are obviously ideals, but these can never be bought at the cost of human dignity or at the price of justice for some.**

**At least for Episcopalians, we can remember that our bishops cannot act alone but must deliberate with lay people, deacons and priests meeting in General Convention, which won't happen until 2009. As an openly gay Episcopal priest, I remain hopeful that my church will act in that convention to reaffirm without compromise the full participation of people like me and my lesbian, bisexual and transgender sisters and brothers in the church.**

**Meanwhile The Center for Lesbian and Gay Studies in Religion and Ministry (CLGS) will continue to work with a variety of organizational partners to provide resources and education on LGBT issues across the country. This kind of biblical, pastoral and theological education is critically important, not only for Episcopalians but for every faith community seeking to affirm the dignity and full participation of all their members as well as full equality for every American citizen, regardless of their gender identity and expression.**
